
Interview Accommodations

Dear Applicant,

Congratulations on your interview at Penn Med! The student hosting program provides overnight accommodations as well as the opportunity to meet Penn medical students. Enclosed is a list of students in the first-year class who have volunteered to house students the night before their interview.

If you would like to stay with a student, please e-mail (preferably) or call one of the people on the attached list at least one week before your interview. For e-mail addresses, unless a complete e-mail address is listed, just append '@mail.med.upenn.edu' to the username. The list is sorted into four groups. The first group of students lives in Center City, which is just across the river from the Penn campus and is close to downtown Philadelphia. The second group of students lives in West Philly, which is just west of campus. The third group lives in the graduate dorms. The fourth group is willing to host applicants but may live further away or have other limitations. Travel time to school from any of the host homes varies between 5-25 minutes walking, so ask your host. In any event, the trip to campus should not be more than a \$5 cab ride.


Please remember that this is a voluntary service. We may not be able to house all applicants and students may have a limited amount of time to spend with you. In an effort to spread out the hosting requests, we ask that applicants whose last names begin with A-L first call among the top half each housing area, and that applicants whose last names begin with M-Z first call among the lower half of each area. 



Thank you for spending the time to meet with me during my visit to the University of Pennsylvania School of Medicine. I hope you will look favorably on my application.







Dear Dr. Grippi,

I recently received notification that I had been placed on the second tier of the waiting list for admission to the University of Pennsylvania School of Medicine. I was somewhat disappointed, but remain heartened by the fact that you are keeping my application open for continuing review.

I want the Office of Admissions to know that the University of Pennsylvania is my first choice for medical school. During my visit, I was very impressed by the medical facilities associated with the school. The medical students I met furthered my interest as they seemed extremely enthusiastic about the school. I was particularly excited by the Penn Med. Curriculum 2000 Program, with its integrated teaching of medical science, biethics and medical economics with clinical exposure to patients, which seems to me one of the most progressive approaches to teaching medicine at any school. I am also interested in eventually pursuing a M.D./M.B.A. Joint Degree Program and I think that the University of Pennsylvania School of Medicine and Wharton School of Business provide an unbeatable combination for anyone considering such a program.

I went to school in the City of Cambridge, in Massachusetts, and thus am extremely aware of the lack of readily accessible / walk-in medical centers for inner city kids and families. I want to specialize in Family Medicine and General Pediatrics, and I dream of being able to provide care to those who need it most, but are unable to afford it. To realize such a dream I will not only need a sound background in medicine but also an understanding of the economic feasibility of establishing a free clinic in the inner city. To this end, I believe that the University of Pennsylvania is the best equipped to help me realize my dream.

In the meantime, I would like to update the Admissions Committee on my more recent academic and extracurricular activities. In November 1998, I was elected to the Student Government at the University of Chicago. As a member of the Student Assembly, I have taken a leadership role in planning student activities including community outreach events, town meetings and study breaks and addressing important student issues like the proposed changes in the U of C's Common Core Curriculum and Student Health Plan. I was also elected to the seven member Student Government Finance Committee, which meets weekly to allocate over \$200,000 of Student Government funds to student organizations for upcoming events, activities and capital improvements.

I have expressed interest in studying health care economics during medical school. Although I have already acquired the necessary credits to graduate, I plan to enroll in another class next quarter; Health Economics and Public Policy, taught by professor David Melzer. This class examines issues related to the economics of American Medicine including the structure of health insurance, the effects of technical changes in medicine, and the policy changes ongoing in the field of medicine with the rise of HMO's and managed care. I hope this class will help me to understand the economic and public policy issues now facing American medicine.

During my interview at the University of Pennsylvania, I told Gaye Sheffler that I wanted to be the next surgeon general of the United States. I admit this is a rather ambitious goal. However, when I look at the dramatic changes that have gone on in the field of medicine over the past decade, I see an amazing opportunity for a good physician who understands the complex public policy and economic issues facing American medicine today. In a leadership role, such a person could dramatically change the structure of the American health care system and revolutionize the way that medicine is practiced in the United States. I want to go to the University of Pennsylvania because I am convinced that your program will teach me how to be a responsible physician dedicated to my patients, as well as how to be a leader in the effort to reform medicine in the United States. I believe that your school can help me to achieve my ambitions.

And, if you call me the day before classes begin, to offer me an opening in your freshman class, I will be in Philadelphia the very same day, ready to attend your medical school.

Dear Mr. Chokalingam:

The Committee on Admissions has completed its review of your application for admission. We enjoyed meeting you during our interview program and found you to be a qualified applicant.

The limitation on the number of places available in the class does not allow us to offer you an acceptance at this time. We are placing your name on a waitlist for admission. Decisions on acceptances from the waitlist may be made at any time, but generally take place no earlier than June and no later than August 11. While there is no individual rank on the waitlist, the Committee has divided the waitlist into two tiers.

Your position on the waitlist is in the <u>second tier</u>. Generally, the Committee on Admissions utilizes the first tier waitlist before offering positions to candidates in the second tier. This means that any second tier acceptance will occur later in the summer, if at all. Based on our experience acceptance offers to waitlist candidates in the second tier are rather unlikely. I hope this information is helpful to you for planning purposes.
